The Indiana Tax Credit Scholarship program allows donors to support private education and receive a 50% Indiana state tax credit. This program is administered through certified Scholarship Granting Organizations (SGOs).

Guerin Catholic is proud to partner with the Institute for Quality Education. Any gift given through this SGO provides needs-based financial assistance to Guerin Catholic students, giving many an opportunity to experience a Guerin Catholic education.

**So, how does it work?**

It's pretty simple: instead of donating directly to the school, you give a gift to the Institute for Quality Education, designating Guerin Catholic as the beneficiary. **The funds still flow directly to the school, and you qualify for a 50% state tax credit in addition to the existing federal deduction.**

Depending on your personal circumstances, this can result in substantial tax savings, greatly reducing the actual cost of your contribution:
